APPLICATION FOR MEMBERSHIP AND FOR ELECTRIC SERVICE CLASS 1

The undersigned (hereinafter called the "Applicant") hereby applies for membership in and agrees to purchase electric energy from **Three Rivers Electric Cooperative** (hereinafter called the "Cooperative") upon the following terms and conditions:

1. The Applicant will pay to the Cooperative the sum of \$0.00 which, if this application is accepted by the Cooperative, will constitute the Applicant's membership fee.
2. The Applicant will, when electric energy becomes available, purchase from the Cooperative all electric energy used on the premises described below and will pay therefore monthly at rates to be determined from time to time in accordance with the bylaws of the Cooperative; provided, however, that the Cooperative may limit the amount of electric energy to be furnished for Industrial uses. The Applicant will pay for electric service at the rate and minimum of the applicable rate schedule.
3. The Applicant will cause his premises to be wired in accordance with wiring specifications approved by the Cooperative.
4. The Applicant will comply with and be bound by the provisions of the charter and bylaws of the Cooperative and such rules and regulations as may from time to time be adopted by the Cooperative.
5. The Applicant, by paying a membership fee and becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law his private property is exempt from execution for any such debts or liabilities.
6. No less than \$4.00 nor more than \$5.00 of the amount accruing to me each year is for a year's subscription to *The Country Circuit and Rural Missouri*.
7. The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, and the contract for electric service shall continue in force for one year from the date service is made available by the Cooperative to the Applicant, and thereafter until cancelled by at last 30 days' written notice given by either party to the other.
8. The Applicant certifies that the one box marked is the predominant use of electricity. If energy purchased results in a sales tax liability due to use other than stated, the Applicant assumes responsibility for remitting such tax due directly to the Director, Missouri Department of Revenue.
